The <IR> process is intended to be applied continuously to all relevant reports and communications, in addition to the preparation of an integrated report. The integrated report may include links to other reports and communications, e.g., financial statements and sustainability reports. The IIRC aims to complement material developed by established reporting standard setters and others, and does not intend to develop duplicate content (paragraphs 1.18-1.20).

Sectin 1.10 points out, that the Framework is intended for application by a.o. for-profit companies of any size. In our view the Framework has been designed for large companies, PIE`s in particular. We strongly believe that, in order to develop a relevant Framework for SME`s, a separate exercise should be undertaken. This exercise should adequately involve relevant stakeholders from the SME-community. Amongst others it should be considered whether the development of a Framework should be limited to larger SME`s, thus omitting smaller ones. In considering the development of such a Framework for SME`s it could prove worthwhile to include different SME`s of different size in the pilot of the present Framework.

In view of this key comment we have abstained from comments on particular elements of the Framework.

## **Chapter 2: Fundamental concepts**

### ***The capitals (Section 2B)***

The Framework describes six categories of capital (paragraph 2.17). An organization is to use these categories as a benchmark when preparing an integrated report (paragraphs 2.19-2.21), and should disclose the reason if it considers any of the capitals as not material (paragraph 4.5).

### ***Business model (Section 2C)***

A business model is defined as an organization's chosen system of inputs, business activities, outputs and outcomes that aims to create value over the short, medium and long term (paragraph 2.26).

Outcomes are defined as the internal and external consequences (positive and negative) for the capitals as a result of an organization's business activities and outputs (paragraphs 2.35-2.36).
